

Review of the Eurodac Regulation	Eurodac = EU-wide biometric fingerprint database of illegally entering migrants, which shall be strengthened in scope and application			
Regulation on Asylum and Migration Management	Replacing the Dublin III Regulation, which determines responsibility for asylum procedures between the Member States and hence the distribution of refugees			
Crisis and Force Majeure Regulation	Introducing exceptions in the asylum procedure and changes in the distribution of refugees in "crisis situations"

Looking ahead

The European Parliament and the EU Council Presidencies for 2022-2024 signed a joint roadmap in September 2022 to declare that all proposals in the package will be brought to a negotiated conclusion by February 2024.

✓ Important to EM Germany

- Finalise the whole package before the European elections in 2024
- Allow EU coordination of sea rescue operations and end criminalisation of civilian sea rescue missions
- Ensure fair and transparent reception of refugees in line with rule of law and avoid imprisonment or conditions similar to imprisonment as far as possible
- Create a permanent, binding solidarity mechanism in the distribution of refugees and focus on positive incentives
- Strengthen legal migration channels

*In addition to the migration and asylum package, there is an agreement on a voluntary, temporary solidarity mechanism in the distribution of refugees between 18 EU Member States, Norway, Switzerland and Liechtenstein. The revision of the Return Directive is not officially part of the Asylum and Migration Package.

**These three proposals of the Juncker Commission were incorporated into the Migration and Asylum Package of 2020. Under the Bulgarian Council Presidency, an agreement was reached in the trilogue in 2018, which, however, has not yet been finally confirmed by the Council. Due to the package solution, the negotiations are on hold.
